

**AN ORDINANCE ESTABLISHING THE BOUNDARIES OF THE DISTRICTS FOR THE ELECTION OF THE MEMBERS OF THE BOARD OF SUPERVISORS AND ESTABLISHING ELECTION PRECINCTS**

BE IT ENACTED BY THE BOARD OF SUPERVISORS OF CLARKE COUNTY, IOWA, THAT:

**SECTION 1. SUPERVISORS DISTRICTS**

The following districts are established pursuant to Iowa Code section 331.210 for the election of members of the Board of Supervisors:

**Supervisors District 1:**

All of the Madison Township, Troy Township, Doyle Township, Knox Township, Green Bay Township, Franklin Township, Jackson Township, and Liberty Township, and that portion of Osceola Township which lies South of the Osceola City Limits and West of U.S. Highway 69.

**Supervisors District 2:**

All of Ward Township, Washington Township, and Fremont Township; all of Osceola Township except the portion of Osceola Township which lies South of the Osceola City Limits and West of U.S. Highway 69; Osceola Precinct One and Precinct Four.

**Supervisors District 3:**

Osceola Precinct Two and Osceola Precinct Three.

**SECTION 2. ELECTION PRECINCTS**

The following voting precincts are established for use during elections, subject to the authority of the County Commissioner of Elections to combine voting precincts as permitted by law:

**Murray Precinct:**

All of Madison Township, Troy Township, including the incorporated town of Murray, and Doyle Township.

**South Middle Precinct:**

All of Knox Township and Green Bay Township, and that portion of Osceola Township which lies South of the Osceola City Limits and West of U.S. Highway 69.

**Woodburn Precinct:**

All of Liberty Township, Jackson Township, including the incorporated town of Woodburn, and Franklin Township.

**North Middle Precinct:**

All of Ward Township, Washington Township, and Fremont Township; all of Osceola Township except that portion of Osceola Township which lies South of the Osceola City Limits and West of U.S. Highway 69; and Precinct Four in the City of Osceola ( as defined by ordinance adopted by the Osceola City council).

**Osceola Precinct One:**

As defined by ordinance adopted by the Osceola City Council.

**Osceola Precinct Two:**

As defined by ordinance adopted by the Osceola City Council.

**Osceola Precinct Three:**

As defined by ordinance adopted by the Osceola City Council.

**SECTION 3. EFFECTIVE DATE**

This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.

**SECTION 4. SEVERABILITY CLAUSE**

If any section, provision, or part of this Ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.
