**March 2, 2020** – The Clarke County Board of Supervisors met in regular session on March 2, 2020, at the Clarke County Courthouse with the following members present: Marvin McCann and Larry Keller. Dean Robins was absent. Also present, Auditor Janice White and Secondary Road Engineer Christian Boehmer. Vice-Chairman Marvin McCann called the meeting to order at 9:00 a.m. Larry Keller made a motion to approve the agenda, seconded by Marvin McCann. All Ayes.

**Res 20-039** – Moved by Larry Keller, seconded by Marvin McCann, to award Bridge Replacement Project No BROS-CO20(93)—5F-20 and approve signing all documentation for this project.  
Vote was: “Ayes”: Marvin McCann and Larry Keller. “Nays”: None. Dean Robins was absent.

**PUBLIC HEARING** The Board of Supervisors met on March 2, 2020, in the Clarke County Courthouse, Board of Supervisor’s room, for a public hearing on the proposed property tax levy for Fiscal Year 20/21. Members present were Marvin McCann and Larry Keller. Dean Robins was absent. Also present, were County Auditor Janice White, Kathleen Johnson, Robert Johnson, Trevor Moore, Bruce Moore, Walter Brant, Judy Moore, Teresa Alatorre and others not signed in.

Moved by Larry Keller to open the hearing at 10:00 A.M., seconded by Marvin McCann. Motion carried.

The auditor explained that Senate File 634 now requires the county to publish a separate notice showing the proposed property tax levy for the general services funds and the rural services funds. The public was interested in different aspects of the county valuation and how the board came up with the amounts needed in the general services area and the rural services area. The board explained how the county was able to lower the rate for the general services funds but had to increase rural services a small amount. The county’s requested tax dollars have decreased from the previous year.

No written comments were received.

Moved by Larry Keller to close the hearing, seconded by Marvin McCann. Motion carried. Hearing closed at 10:20 A.M.

**Res 20-042** – WHEREAS, the Clarke County Board of Supervisors have considered the proposed Fiscal Year 20/21 county maximum property tax dollars for both General County Services and Rural County Services, and

WHEREAS, a notice concerning the proposed county maximum property tax dollars was published as required and posted on county website, and

WHEREAS, a public hearing concerning the proposed county maximum property tax dollars was held on March 2, 2020.

NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of Clarke County that the maximum property tax dollars for General County Services and Rural County Services for Fiscal Year 20/21 shall not exceed the following:

General County Services – \$3,295,808; a decrease of 6.09% from the prior year

Rural County Services – \$1,189,770; an increase of .24% from the prior year

The Maximum Property Tax dollars requested in either General County Services or Rural County Services for Fiscal Year 20/21 does not represent an increase of 102% from the Maximum Property Tax dollars requested for Fiscal Year 19/20.

Motion was made by Larry Keller and seconded by Marvin McCann.

Vote was, “Ayes”: Marvin McCann and Larry Keller. “Nays”: None. Dean Robins was absent.

**Res 20-043** – Moved by Larry Keller, seconded by Marvin McCann to set March 23, 2020, at 10:00 a.m. as the date and time to hold a public hearing on the proposed fiscal year 2020-2021 county budget.
