February 22, 2021 – The Clarke County Board of Supervisors met in regular session on February 22, 2021, at the Clarke County Courthouse with the following members present: Dean Robins, Larry Keller and Austin Taylor. Also present, Auditor Janice White. Chairman Dean Robins called the meeting to order at 9:00 a.m. Larry Keller made a motion to approve the agenda, seconded by Austin Taylor. All Ayes.

Engineer Christian Boehmer arrived at 9:02 a.m.

Res 21-025 – The Board of Supervisors met February 22, 2021, at 9:00 a.m. to consider bids for the Local Letting for Rock Resurfacing Project # FM-CO20(120)—55-20.

Only one bid was received and it was from Schildberg Construction Co. Inc., 108 S.E. 6th Street, Greenfield, IA 50849:

Surface Granular, Class D Crushed Stone, 1,750 Tons @ \$18.10 = \$31,675
Surface Granular, Class D Crushed Stone, 18,750 Tons @ \$20.10 = \$376,875
Surface Granular, Class A Crushed Stone, 2,990 Tons @ 19.45 = \$58,155.50
Total Bid = \$466,705.50
