**May 10, 2021** – The Clarke County Board of Supervisors met in regular session on May 10, 2021, at the Clarke County Courthouse with the following members present: Dean Robins and Larry Keller. Austin Taylor was absent. Also present, Auditor Janice White. Chairman Dean Robins called the meeting to order at 9:00 a.m. Larry Keller made a motion to approve the agenda, seconded by Dean Robins. All Ayes.

**Res 21-067** – Moved by Larry Keller, seconded by Dean Robins to accept the Cost Allocation Plan as prepared by Cost Advisory Services, Inc. based on fiscal year ended June 30, 2020, to establish cost allocations for use in fiscal year 2022 and sign Certification Statement.
