**May 24, 2021** – The Clarke County Board of Supervisors met in regular session on May 24, 2021, at the Clarke County Courthouse with the following members present: Dean Robins, Larry Keller and Austin Taylor. Also present, Auditor Janice White and Osceola Sentinel-Tribune Editor Tyra Audlehelm. Chairman Dean Robins called the meeting to order at 9:00 a.m. Larry Keller made a motion to approve the agenda, seconded by Austin Taylor. All Ayes.

**Res 21-075** – The Board of Supervisors met on May 24, 2021, for a public hearing to vacate a section of Clarke County Secondary Roads, described as follows: Beginning at the intersection of Fox Lane and Fox Street in the Northwest Quarter (NW1/4) of Section 1, Township 71 North, Range 24 West, and terminating at the end of Fox Lane approximately 965.94 feet. Members present were Dean Robins, Larry Keller and Austin Taylor. Also present, in addition to the Board Members, were County Auditor Janice White, County Engineer Christian Boehmer, Secondary Road Office Manager Cindy West and Osceola Sentinel-Tribune Editor Tyra Audlehelm.

Moved by Larry Keller to open the hearing at 9:02 A.M., seconded by Austin Taylor. Motion carried.

Ms. West explained that Secondary Road is in favor of it. Owner owns all sides of the lane. She has received no objections.

There were no objections in person or in writing to either the Auditor or the Board.

After discussion, it was moved by Larry Keller to close the hearing. Austin Taylor seconded. Motion carried. Hearing closed at 9:09 a.m.

Austin Taylor made a motion to approve vacating the above described Fox Lane in Section 1 of Franklin Township. Seconded by Larry Keller.
