July 12, 2021 – The Clarke County Board of Supervisors met in regular session on July 12, 2021, at the Clarke County Courthouse with the following members present: Dean Robins, Larry Keller and Austin Taylor. Also present, Auditor Janice White, Treasurer Jessica Smith and Osceola-Sentinel Tribune Editor Tyra Audlehelm. Chairman Dean Robins called the meeting to order at 9:00 a.m. Larry Keller made a motion to approve the agenda, seconded by Dean Robins. All Ayes.

Res 21-094 - Moved by Larry Keller, seconded by Austin Taylor to approve the following resolution approving final plat of Timber Creek Estates Subdivision located in Section 28 of Fremont Township, in Clarke County, Iowa.

WHEREAS, there was filed with said plat a dedication of said plat, containing a statement to the effect that the subdivision as it appears on the plat is with free consent and in accordance with the desire of the owners, Gary Knight and Rebecca Knight; and

WHEREAS, said plat was accompanied by an opinion from an attorney at law showing that title in fee simple is in said owners, and that the platted land is free from encumbrance; and

WHEREAS, a statement has been filed by the County Auditor approving the unique name of Timber Creek Estates Subdivision; and

WHEREAS, a statement has been filed by the County Engineer whereby they raised no objections to the proposed subdivision; and

WHEREAS, a statement has been filed by the County Treasurer stating that there are no unpaid property taxes forming a lien against any real estate to be a part of this subdivision; and

WHEREAS, the Board of Supervisors of Clarke County, Iowa, find that said plat conforms to the provisions of the Ordinances of Clarke County, Iowa, and that the plat, papers and documents presented therewith should be approved by the Clarke County Board of Supervisors, and that said plat, known as Timber Creek Estates Subdivision, should be approved by the Clarke County Board of Supervisors;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Clarke County, Iowa, that said plat, known as Timber Creek Estates Subdivision, prepared in connection with said plat and subdivision, is hereby approved.

Her raise will be \$2,250 making her total salary \$102,250 which is to be divided equally between Decatur and Clarke. Clarke’s share will be \$51,125.
