**June 21, 2021** – The Clarke County Board of Supervisors met in regular session on June 21, 2021, at the Clarke County Courthouse with the following members present: Dean Robins, Larry Keller and Austin Taylor. Also present, Auditor Janice White, Secondary Road Office Manager Cindy West and Osceola-Sentinel Tribune Editor Tyra Audlehelm. Chairman Dean Robins called the meeting to order at 9:00 a.m. Larry Keller made a motion to approve the agenda, seconded by Austin Taylor. All Ayes.

**Res 21-085** – The Board of Supervisors met on June 21, 2021, for a public hearing to vacate a section of Clarke County Secondary Roads, described as follows: Beginning at the west boundary line of 2208 Milo Street going eastward for approximately 540 yards towards I-35 to the point where the road is currently closed. This is all in Section 31, Township 73 North, Range 25 West. Members present were Dean Robins, Larry Keller and Austin Taylor. Also present, in addition to the Board Members, were County Auditor Janice White, Secondary Road Office Manager Cindy West and Osceola Sentinel-Tribune Editor Tyra Audlehelm.

Moved by Larry Keller to open the hearing at 9:02 A.M., seconded by Austin Taylor. Motion carried.

Ms. West explained that Secondary Road is in favor of closing the above.

There were no objections in person or in writing.

After discussion, it was moved by Larry Keller to close the hearing. Austin Taylor seconded. Motion carried. Hearing closed at 9:05 a.m.

Larry Keller made a motion to approve vacating the above-described portion of Milo Street in Section 3, Fremont Township. Seconded by Austin Taylor.

Vote was “Ayes”: Dean Robins, Larry Keller and Austin Taylor. “Nays”: None.

**Res 21-086** – Moved by Larry Keller, seconded by Austin Taylor to approve fourth quarter transfer of funds, in the amount of \$13,946.75, from the General Supplement Fund to the Emergency Management Fund.

**Res 21-087** – WHEREAS, the State of Iowa has appropriated moneys for the fiscal year July 1, 2021 through June 30, 2022 and

WHEREAS, said moneys can be insufficient to fund the various local property tax credits/exemptions fully, and

WHEREAS, according to Iowa Code Section 25B.7 “If a state appropriation made to fund a credit or exemption which is enacted on or after January 1, 1997, is not sufficient to fully fund the credit or exemption, the political subdivision shall be required to extend to the taxpayer only that portion of the credit or exemption estimated by the Department of Revenue and Finance to be funded by the state appropriation”, and

WHEREAS, the Iowa Department of Revenue and Finance has estimated the percentages of state funding for the affected property tax credits/exemptions as follows: Homestead and Disabled Veterans credit 100%, Elderly low-income credit 100%, Military exemption credit 100%, Ag Land credit 20.48743124% and Family Farm credit 14.48028888%

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Clarke County, Iowa, that pursuant to Iowa Code Section 25B.7, to extend to the taxpayer property tax credits/exemptions as funded by the State of Iowa according to the percentages stated above for the fiscal year 2021-22.

Moved by Austin Taylor, seconded by Larry Keller, that this resolution be adopted.

Vote was, “Ayes”: Dean Robins, Larry Keller and Austin Taylor. “Nays”: None.

**Res 21-088** – Moved by Austin Taylor, seconded by Larry Keller, to approve the Family Farm tax credits to be applied to the 2021-22 tax lists, except those denied by the Board of Supervisors due to the fact that they do not qualify for the credit.

Vote was, “Ayes”: Dean Robins, Larry Keller and Austin Taylor. “Nays”: None.
