January 17, 2022 – The Clarke County Board of Supervisors met in regular session on January 17, 2022, at the Clarke County Courthouse with the following members present: Dean Robins, Larry Keller and Austin Taylor. Also present, Auditor Janice White. Chairman Dean Robins called the meeting to order at 9:00 a.m. Larry Keller made a motion to approve the agenda, seconded by Dean Robins. All Ayes.

Res 22-008 – Moved by Austin Taylor, seconded by Larry Keller to set February 28, 2022, at 9:00 a.m. as the date and time for rock letting for Farm to Market Rock Resurfacing Project FM-CO20(125)—55-20
