**January 31, 2022** – The Clarke County Board of Supervisors met in regular session on January 31, 2022, at the Clarke County Courthouse with the following members present: Dean Robins, Larry Keller and Austin Taylor. Also present, Auditor Janice White, Engineer Christian Boehmer, Office Manager Cindy West, Greg Kent, Brian Fuller, Harold Fuller, Katie Jolliff and Shawn Phelps with United Farmers Cooperative, and Loren Gerleman with Agriland FS. Chairman Dean Robins called the meeting to order at 9:00 a.m. Larry Keller made a motion to approve the agenda, seconded by Austin Taylor. All Ayes.
