**February 23, 2022** – The Clarke County Board of Supervisors met in regular session on February 23, 2022, at the Clarke County Courthouse with the following members present: Dean Robins, Larry Keller and Austin Taylor. Also present, Auditor Janice White and Secondary Road Office Manager Cindy West. Chairman Dean Robins called the meeting to order at 9:00 a.m. Larry Keller made a motion to approve the agenda, seconded by Austin Taylor. All Ayes.

**Res 22-032** – Moved by Larry Keller, seconded by Austin Taylor, to approve entering into a loan agreement with American State Bank for the purchase of a 2021 CAT Motor Patrol for a net cost of \$235,492 (includes trade-in of two patrols), to be repaid in the next five years and payments are to be made from Secondary Road fund. Purchase of this machine was previously approved by resolution.
