**February 28, 2022** – The Clarke County Board of Supervisors met in regular session on February 28, 2022, at the Clarke County Courthouse with the following members present: Dean Robins, Larry Keller and Austin Taylor. Also present, Auditor Janice White, Engineer Christian Boehmer, Engineer Tech Corey Eckels, Head Custodian Russell Johnson and Conservation Director Scott Kent. Chairman Dean Robins called the meeting to order at 9:00 a.m. Larry Keller made a motion to approve the agenda, seconded by Austin Taylor. All Ayes.

**Res 22-039** – The Board of Supervisors met February 28, 2022, at 9:00 a.m. to consider bids for the Local Letting for Rock Resurfacing Project # FM-CO20(125)—55-20.

The following is the only bid received and it was from Schildberg Construction Co. Inc., 108 S.E. 6<sup>th</sup> Street, Greenfield, IA 50849:

Surface Granular, Class D Crushed Stone:

1. Surface Granular 7,070 Tons @ \$21.00 = \$148,470.00
2. Surface Granular 4,290 Tons @ \$22.25 = \$ 95,452.50
3. Surface Granular 5,180 Tons @ \$22.80 = \$112,924.00

Surface Granular, Class A Crushed Stone:

1. Surface Granular 2,080 Tons @ \$21.00 = \$ 43,680.00
2. Surface Granular 6,240 Tons @ \$22.25 = \$138,840.00

Total Bid = \$539,366.50

BE IT RESOLVED, that the Board of Supervisors will request proposals inviting Certified Public Accountants to bid on the annual audit of the County funds for the year ending June 30, 2022, and accrual accounting help and advisement, and also for a three year contract for the years ending June 30, 2022, 2023 and 2024.

BE IT FURTHER RESOLVED, that after all proposals have been evaluated by the County, the Board will consider awarding a contract to a Certified Public Accountant for these audits.

The procedures for these actions will be done in accordance with administrative rules prescribed by the State Auditor’s office.

Let it be noted, the Board reserves the right, after consideration of the Certified Public Accountants’ proposals, not to award a contract to a Certified Public Accountant. At that time the Board may request the State Auditor’s office to perform the audit for the periods the Board designates.
