**July 11, 2022** – The Clarke County Board of Supervisors met in regular session on July 11, 2022, at the Clarke County Courthouse with the following members present: Dean Robins, Larry Keller and Austin Taylor. Also present, Auditor Janice White, Recorder Peggy Cummings, Engineer Christian Boehmer and Secondary Road Office Manager Cindy West.
