August 15, 2022 – The Clarke County Board of Supervisors met in regular session on August 15, 2022, at the Clarke County Courthouse with the following members present: Dean Robins, Larry Keller and Austin Taylor. Also present, Auditor Janice White, News Editor Candra Brooks, County Attorney Adam Ramsey and Water Superintendent Brandon Patterson.
