Clarke County Board of Supervisors September 7, 2022

September 7, 2022 - The Clarke County Board of Supervisors met in regular session on September 7, 2022, at the Clarke County Courthouse with the following members present: Dean Robins and Larry Keller. Austin Taylor attended by phone. Also present, Auditor Janice White and Osceola Sentinel Editor Candra Brooks. Chairman Dean Robins called the meeting to order at 9:00 a.m. Larry Keller made a motion to approve the agenda, seconded by Austin Taylor. All Ayes.

Res 22-148 – Moved by Larry Keller, seconded by Austin Taylor to increase the Board of Health from a five-member board to a seven-member board, per Iowa Code Section 137, effective September 7, 2022.

Res 22-149 – Moved by Austin Taylor, seconded by Larry Keller to appoint Tom Bahls to Clarke County Board of Health to finish the term of Teri Johnston, who has resigned, ending December 31, 2023; and to appoint new board members Brian Crawford and Paula McClaflin for three-year terms ending December 31, 2025. This will now increase the Board of Health to a seven-member board.

Res 22-150 – Moved by Larry Keller, seconded by Austin Taylor to change General Assistance from Community Services Coordinator to Veterans Affairs Director. This will reduce the hours worked by the Community Services Coordinator to 35 hours. Her duties with CROSS MHDS Region, on behalf of Clarke County, have increased and the CROSS MHDS Region recommends no change in her salary. The Veterans Affairs Director will increase her hours to full time, at 35 hours a week, with her hourly rate staying the same. She will be paid 80% out of Veterans Affairs budget and 20% out of General Relief budget. This change will begin on September 12, 2022.
