**December 19, 2022** - The Clarke County Board of Supervisors met in regular session on December 19, 2022, at the Clarke County Courthouse with the following members present: Dean Robins, Larry Keller and Austin Taylor. Also present, Auditor Janice White, Osceola Sentinel Editor Candra Brooks, Randy Dunbar, Engineer Christian Boehmer and Secondary Road Office Manager Cindy West.
