**January 23, 2023** - The Clarke County Board of Supervisors met in regular session on January 23, 2023, at the Clarke County Courthouse with the following members present: Dean Robins, Austin Taylor and Randy Dunbar. Also present, Auditor Janice White, Secondary Road Office Managers Cindy West and Jill Curnes, Osceola Sentinel Editor Candra Brooks, Loren Gerleman with Agriland FS, Katie Jolliff and Darin Schlapia with United Farmers Cooperative, Brian Fuller and Harold Fuller. Chairman Dean Robins called the meeting to order at 9:00 a.m. Randy Dunbar made a motion to approve the agenda, seconded by Austin Taylor. All Ayes.

Fuel bids were opened but no action was taken at this time to award a contract for the fuel. More research will be done, with a possible decision at the next meeting.
