May 15, 2023 - The Clarke County Board of Supervisors met in regular session on May 15, 2023, at the Clarke County Courthouse with the following members present: Dean Robins, Austin Taylor and Randy Dunbar. Also present, Auditor Janice White, Osceola Sentinel Editor Candra Brooks. Chairman Dean Robins called the meeting to order at 9:00 a.m. Randy Dunbar made a motion to approve the agenda, seconded by Austin Taylor. All Ayes.

Res 23-085 - Moved by Randy Dunbar, seconded by Dean Robins, to approve installation of official national historic trail signs for the Mormon Pioneer National Historic Trail in rural Clarke County with the County supplying the posts and hardware.
