## Clarke County Board of Supervisors February 21, 2024

**February 21, 2024** - The Clarke County Board of Supervisors met in regular session on February 21, 2024 at the Clarke County Courthouse with the following members present: Austin Taylor, Dean Robins and Randy Dunbar. Also present, Auditor Janice White and Osceola Sentinel Editor Candra Brooks. Chairman Austin Taylor called the meeting to order at 9:00 a.m. Randy Dunbar made a motion to approve the agenda, seconded by Dean Robins. All Ayes.

**Res 24-031** - Moved by Dean Robins, seconded by Randy Dunbar to approve the following resolution approving final plat of C & J Estates Minor Subdivision located in Section 17 of Knox Township, in Clarke County, Iowa.
