July 22, 2024 - The Clarke County Board of Supervisors met in regular session on July 22, 2024 at the Clarke County Courthouse with the following members present: Austin Taylor, Dean Robins and Randy Dunbar. Also present, Auditor Janice White, Osceola Sentinel Editor Candra Brooks, Jim Hume, Don Heck, Assistant County Attorney Johanna Olson and County Attorney Office Manager Chris Dorsey. Chairman Austin Taylor called the meeting to order at 9:00 a.m. Dean Robins made a motion to approve the agenda, seconded by Randy Dunbar. All Ayes.

Res 24-138 - Moved by Dean Robins, seconded by Austin Taylor, to approve Southern Iowa Trolley's request for county support for fiscal year 2025, in the amount of \$11,923.

Res 24-139 - WHEREAS, the State of Iowa has appropriated moneys for the fiscal year July 1, 2024 through June 30, 2025 and

WHEREAS, said moneys can be insufficient to fund the various local property tax credits/exemptions fully, and

WHEREAS, according to Iowa Code Section 25B.7 "If a state appropriation made to fund a credit or exemption which is enacted on or after January 1, 1997, is not sufficient to fully fund the credit or exemption, the political subdivision shall be required to extend to the taxpayer only that portion of the credit or exemption estimated by the Department of Revenue and Finance to be funded by the state appropriation", and

WHEREAS, the Iowa Department of Revenue and Finance has estimated the percentages of state funding for the affected property tax credits/exemptions as follows: Homestead and Disabled Veterans credit 100%, Elderly low-income credit 100%, Ag Land credit 21.1947745% and Family Farm credit 15.6140022%

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Clarke County, Iowa, that pursuant to Iowa Code Section 25B.7, to extend to the taxpayer property tax credits/exemptions as funded by the State of Iowa according to the percentages stated above for the fiscal year 2025-26.

Moved by Randy Dunbar, seconded by Austin Taylor, that this resolution be adopted.
