**September 16, 2024** - The Clarke County Board of Supervisors met in regular session on September 16, 2024 at the Clarke County Courthouse with the following members present: Dean Robins and Randy Dunbar. Austin Taylor was absent. Also present, Auditor Janice White, Osceola Sentinel Editor Candra Brooks, Secondary Road Office Manager Jill Curnes, and Greg Stith. Vice-Chairman Dean Robins called the meeting to order at 9:00 a.m. Randy Dunbar made a motion to approve the agenda, seconded by Dean Robins. All Ayes.
