November 25, 2024 - The Clarke County Board of Supervisors met in regular session on November 25, 2024 at the Clarke County Courthouse with the following members present: Austin Taylor and Dean Robins. Randy Dunbar via phone. Also present, Deputy Auditor Jessica Graves, Osceola Sentinel Editor Candra Brooks, and Ronnie Decker.
