**February 10, 2025** - The Clarke County Board of Supervisors met in regular session on February 10, 2025 at the Clarke County Courthouse with the following members present: Dean Robins, Randy Dunbar, and Brian Sorensen. Also present, Auditor Jessica Graves, Osceola Sentinel Editor Candra Brooks, Ronnie Decker and Greg Stith. Chairman Randy Dunbar called the meeting to order at 9:00 a.m. Dean Robins made a motion to approve the agenda, seconded by Brian Sorensen. All Ayes.

**PUBLIC HEARING #25-028**

The Board of Supervisors met on February 10, 2025, for a public hearing to amend the Clarke County Budget for fiscal year 2024-25. Members present were Randy Dunbar, Dean Robins, and Brian Sorensen. Also present, County Auditor Jessica Graves, Osceola Sentinel Editor Candra Brooks, and Ronnie Decker.

Moved by Dean Robins to open the hearing at 9:15 a.m. Seconded by Brian Sorensen. Ayes all.

Ronnie Decker asked why an amendment was needed. The Board explained the budget amendment was to amend Conservation for donations and related expenses, Public Health for vaccines revenue and expenses, payment of American Rescue Plan Act funds, the bond income and expense and other items as listed on the published amendment.

There were no objections in writing.

It was moved by Dean Robins to close the hearing. Brian Sorensen seconded. Ayes all.

Hearing closed at 9:20 a.m.,

Dean Robins made a motion to approve the fiscal year 2024-25 County Budget Amendment and Department Appropriations as published. Seconded by Brian Sorensen.

No action was taken on deputy appointments.

**Res 25-030** - Moved by Dean Robins, seconded by Brian Sorensen, to approve second and third quarter transfer of funds, in the amount of \$40,500, from the General Supplement Fund to the Emergency Management Fund.
