**March 10, 2025** - The Clarke County Board of Supervisors met in regular session on March 10, 2025 at the Clarke County Courthouse with the following members present: Dean Robins, Randy Dunbar, and Brian Sorensen. Chairman Randy Dunbar called the meeting to order at 9:00 a.m. Dean Robins made a motion to approve the agenda, seconded by Brian Sorensen. All Ayes.
