April 21, 2025 - The Clarke County Board of Supervisors met in regular session on April 21, 2025 at the Clarke County Courthouse with the following members present: Randy Dunbar, Dean Robins, and Brian Sorensen. Also present, Auditor Jessica Graves and Osceola Sentinel Editor Candra Brooks, County Assistant Engineer Corey Eckels, Ronnie Decker, and Robert Johnson. Chairman Randy Dunbar called the meeting to order at 9:00 a.m. Dean Robins made a motion to approve the agenda, seconded by Brian Sorensen. All Ayes.

The Board of Supervisors met on April 21, 2025, with Board Members, Randy Dunbar, Dean Robins, and Brian Sorensen present for a public hearing on the proposed Clarke County Budget for fiscal year 2025-26. Auditor Jessica Graves, Osceola Sentinel Editor Candra Brooks, County Assistant Engineer Corey Eckels, Ronnie Decker, and Robert Johnson were also present.

There were questions from the public regarding revenue from taxes, public safety and legal services. Another public member expressed concern over increases in taxes.
