The Clarke County Board of Supervisors met in regular session on May 28, 2025 at the Clarke County Courthouse with the following members present: Randy Dunbar, Dean Robins, and Brian Sorensen. Chairman Randy Dunbar called the meeting to order at 9:00 a.m. Dean Robins made a motion to approve the agenda, seconded by Brian Sorensen. All Ayes.

PUBLIC HEARING RESOLUTION - 25-091 The Board of Supervisors met on May 28, 2025, in the Clarke County Courthouse, Board of Supervisor's room, for a public hearing to vacate a portion of Doyle St. in Section 16 and 21 of Doyle Township. Members present were Randy Dunbar, Dean Robins, and Brian Sorensen. Also present, Auditor Jessica Graves, Clarke County Assistant Engineer Corey Eckels, Osceola Sentinel Editor Candra Brooks and Ronnie Decker. Chairman Randy Dunbar called the hearing to order at 9:00 a.m. Dean Robins made a motion to open the hearing, seconded by Brian Sorensen. All Ayes.

Ronnie Decker asked why the road was being closed and if we currently have gated roads.
