The Clarke County Board of Supervisors met in regular session on August 18, 2025 at the Clarke County Courthouse with the following members present: Randy Dunbar, Dean Robins, and Brian Sorensen. Also present, Deputy Auditor Jill Curnes, Sheriff Rob Kovacevich, and Ronnie Decker. Chairman Randy Dunbar called the meeting to order at 9:00 a.m. Brian Sorensen made a motion to approve the agenda, seconded by Dean Robins. All Ayes.

**Res – 25-135** - Certificate of Appointment of Commissioners of the Housing Authority of the County of Clarke, Iowa

Whereas, The Board of Supervisors of Clarke County, Iowa held a duly authorized regular meeting on the 18<sup>th</sup> day of August, 2025;

Whereas, at said meeting the following resolution was passed and adopted:

Be it Resolved by the Board of Supervisors of the County of Clarke, Iowa That the Board of Supervisors for County of Clarke, Iowa hereby make the following resolution.

Whereas, a resolution has been passed and adopted entitled “Resolution Approving an Authorizing the Execution of a Certain Joint Exercise of Powers Agreement for the Purpose of Creating Multi-County Housing Authority.”

Now, Therefore, Pursuant to the provision of Chapter 28E. Code of Iowa and by virtue of our office as Supervisors, we hereby appoint Michael Hill for three years, as the one person to serve as Commissioner of the Southern Iowa Regional Housing Authority, representing the County of Clarke, Iowa and to serve for the number of years appearing after his name, respectively from the ninth day of April, 2028.
