The Clarke County Board of Supervisors met in regular session on September 15, 2025 at the Clarke County Courthouse with the following members present: Randy Dunbar, Dean Robins, and Brian Sorensen. Also present, Auditor Jessica Graves, Osceola Sentinel Editor Candra Brooks, Ronnie Decker, Kathleen Johnson, and Greg Stith. Chairman Randy Dunbar called the meeting to order at 9:01 a.m. Brian Sorensen made a motion to approve the agenda, seconded by Dean Robins. All Ayes.

During public comment, Ronnie Decker delivered a petition titled "Citizens against wind turbines. We say no to the wind turbines. Citizens of Clarke County have spoken."
