The Clarke County Board of Supervisors met in regular session on April 20, 2026 at the Clarke County Courthouse with the following members present: Randy Dunbar, Dean Robins, and Brian Sorensen. Also present, Auditor Jessica Graves, Osceola Sentinel Editor Candra Brooks and Ronnie Decker. Chairman Randy Dunbar called the meeting to order at 9:00 a.m. Dean Robins made a motion to approve the agenda, seconded by Brian Sorensen. All Ayes.
