May 11, 2026

The Clarke County Board of Supervisors met in regular session on May 11, 2026 at the Clarke County Courthouse with the following members present: Randy Dunbar, Dean Robins, and Brian Sorensen. Also present, Auditor Jessica Graves and Osceola Sentinel Editor Candra Brooks. Chairman Randy Dunbar called the meeting to order at 9:00 a.m. Brian Sorensen made a motion to approve the agenda, seconded by Dean Robins. All Ayes.

**Res 26-077** - The Board of Supervisors met on May 11, 2026, for a public hearing to amend the Clarke County Budget for fiscal year 2025-26. Members present were Randy Dunbar, Dean Robins, and Brian Sorensen. Also present, County Auditor Jessica Graves, Osceola Sentinel Editor Candra Brooks, and Ronnie Decker.

Moved by Brian Sorensen to open the hearing at 9:00 a.m. Seconded by Dean Robins. Ayes all.

**Res 26-079** - RESOLUTION FOR ROAD VACATION PUBLIC HEARING

**WHEREAS**, a request from the Clarke County Engineer has been filed with the Clarke County Board of Supervisors asking that action be taken to vacate and close a section of Clarke County Secondary Road, described as follows:

East Hopeville

Vacating the North/South and East/West portion of Right of Way in Blocks 1-15 of East Hopeville, commonly shown as alley ways in Clarke County, Iowa.

Vacating the entire North/South of Right of Way adjacent to the East side of Block 1, 6, 7, 12, & 13 of East Hopeville in Clarke County, Iowa.

Vacating the entire North/South portion of Right of Way in between Blocks 1 & 2, 6 & 5, 7 & 8, 12 & 11, and 13 & 14 of East Hopeville in Clarke County, Iowa.

Vacating the entire North/South portion of Right of Way in between Blocks 2 & 3, 5 & 4, 8 & 9, 11 & 10, and 14 & 15 of East Hopeville in Clarke County, Iowa.

Vacating the East/West portion of Right of Way adjacent to the North side of Block 1 & 2 of East Hopeville in Clarke County, Iowa.

Vacating the entire East/West portion of Right of Way in between Blocks 6 & 7, 5 & 8, and 4 & 9 of East Hopeville in Clarke County, Iowa.

Vacating the entire East/West portion of Right of Way in between Blocks 7 & 12, 8 & 11, and 9 & 10 of East Hopeville in Clarke County, Iowa.

Vacating the entire East/West portion of Right of Way in between Blocks 12 & 13, 11 & 14, and 10 & 15 of East Hopeville in Clarke County, Iowa.

Original Hopeville

Vacating the North/South and East/West portion of Right of Way in Block 1, 2, 5, 6, 7, 10, 11 of Original Hopeville in Clarke County, Iowa.

Vacating the entire North/South portion of Right of Way in between Blocks 1 & 2, 6 & 5, 7 & the Public Square, 11 & 10, and 12 & 13 of Original Hapeville.

Vacating the entire North/South portion of Right of Way adjacent to the East side of Block 7 of Original Hopeville.

Vacating the entire East/West portion of Right of Way in between Blocks 1 & 6, 2 & 5, and 3 & 4 of Original Hopeville.

Vacating the entire East/West portion of Right of Way in between Blocks 4 & 8 Original Hopeville. Vacating the entire East/West portion of Right of Way in between Blocks 8 & 9 of Original Hopeville. Vacating the entire East/West portion of Right of Way in between Blocks 9 & 14 of Original Hopeville.

**NOW, THEREFORE BE IT RESOLVED** that a hearing on the proposed vacation will be held in the Board Room, Clarke County Courthouse, Osceola, Iowa, 50213, at 9:00 AM on Monday, June 29th, 2026 in accordance with Iowa Code Chapter 306.
