Res 26-156 - The Board of Supervisors met on August 24, 2026 in the Clarke County Courthouse, Board of Supervisor's room, for a public hearing to vacate roads and alleys in the unincorporated town of Jamison. Members present were Randy Dunbar, Dean Robins, and Brian Sorensen. Also present, Auditor Jessica Graves, Clarke County Assistant Engineer Corey Eckels,

Zoning Administrator Lawra Mathes, Clarke County Assessor Heidi Henry, Osceola Sentinel Editor Candra Brooks and members of the public. Chairman Randy Dunbar called the hearing to order at 9:30 a.m. Dean Robins made a motion to open the hearing, seconded by Brian Sorensen. All Ayes.

Corey Eckels stated the roads and alleys in Jamison were being vacated to clean up the area and give the land to the adjacent owners.

A question was asked how the closing of the alleys would impact their taxes.
